### CIRCULAR 13/18

#### **TO ALL EMPLOYERS AND EMPLOYEES** *(Excluding Employer and Employees in the Free State Province)*

#### **NATIONAL MINIMUM WAGE RATES**

The National Minimum Wage Bill was signed into law, and the implementation of the National Minimum Wage Act, 2018, Act No 9 of 2018 comes into effect from **1 January 2019**. In terms of the National Minimum Wage Act, the national minimum hourly rate of pay is R20-00 for each ordinary hour worked.

At the Industry's Annual Wage Negotiations in 2017, it was unanimously agreed by all the Parties to the Council, that in the event that the Government implements the **national minimum wage** or any amendment thereto after 1 May 2018, and the hourly rates of pay of the employees are below the national minimum hourly rate of pay of their respective occupational skills levels, such hourly rates of pay shall be adjusted to the national minimum hourly rate of pay in accordance with the implementation date of the National Minimum Wage Act.

#### **Prescribed minimum hourly rates of pay effective from the establishment's first full pay week in January 2019:**
